COMMERCIAL LEASE TAX

As Florida's legislators advance bills (SB 140, HB 101) to phase out sales taxes on commercial property leases, a broad consortium of commercial real estate organizations assert that the taxes slow economic development, hamper job creation, impair competition for corporate relocations to Florida, and subject businesses to disproportionate regulatory burdens. They are calling for a letter writing campaign to Governor Scott to support the tax relief.

NEW BUILDING CODE IN EFFECT

Florida's 2013 Building Code became effective the first of this year. A "Building Code Boot Camp" will provide training on advanced building code, accessibility and energy code rules. The free training session is presented by AIA Florida Southwest, Florida Home Builders Association, and state agencies April 21st in Estero. Register online at LearnFloridaBuildingCodes.com

FLOOD INSURANCE SURCHARGE

Surcharges on flood insurance policies begin April 1st. The annual surcharge for a primary residence is \$25 and the surcharge for non-primary residences, commercial buildings, and condominium building associations is \$250. The surcharges apply to all policies, including preferred risk policies for properties not in special flood hazard areas. The maximum deductible available increases to \$10,000 on April 1st also. The surcharges are part of the Homeowner Flood Insurance Affordability Act of 2014.

LAND USE SYMPOSIUM

The 2nd Annual Land Use Symposium, "Everything You Wanted to Know About Florida Planning and Zoning - A Symposium for Plan Commissioners and Professionals," will be May 8th in Port Charlotte. LEGISLATIVE WRAP-UP

LEGISLATIVE ACTION REPORT

Commercial Lease Tax (SB 140, HB 101):

A bill to reduce Florida's 6% sales tax on commercial leases passed the Senate Finance & Tax Committee March 23rd with unanimous support. The bill is now in the Appropriations Committee. The comparable House bill, HB 101, is in Finance & Tax Committee.

Water Management:

Comprehensive water policy bills (HB 7003, SB 918) focus on improving and protecting water quality for springs and Lake Okeechobee. House bill passed 106-9, Senate bill in Environmental Preservation & Conservation Committee. The Senate bill includes stricter guidelines and deadlines for protecting springs and creates an advisory council to recommend water projects for funding to the Legislature.

Private Property Rights (HB 383):

Addresses settlement agreements between private entities and government, creates cause of action for damages from unconstitutional takings, and authorizes awards. Filed by Civil Justice Subcommittee, now in Local Government Affairs Subcommittee.

Enterprise Zones (SB 392):

Revises Florida Enterprise Zone Act and conditions for designating an Enterprise Zone. In committees to review.

Plan Amendments (SB 832):

Clarifies requirements for plan amendments to an adopted sector plan and revises regulations regarding mitigation. Community Affairs Committee is reviewing.

Regional Planning Councils (SB 484, HB 873):

Florida's 11 regional planning councils would be eliminated, with much of their authority transferring to local governments. Bills are advancing through committees.

Growth Management (SB 562, HB 933):

The "development of regional impact" (DRI) review process for major projects would be eliminated. Passed Senate Community Affairs and Transportation Committees, now in Rules Committee.

Flood Insurance (CS/HB 895):

Authorizes flexible flood insurance. Appropriations Committee approved, now in Regulatory Affairs Committee.
