COLLIER COUNTY HOUSING STUDY

The Urban Land Institute (ULI) has presented the initial report on it's study of housing issues in Collier County. The <u>report</u> recommends a comprehensive rewrite of the Land Development Code to differentiate urban and rural areas. Other recommendations focus on increasing densities, renovating older housing, and converting unused commercial properties to develop much needed affordable housing. Parking and on-site infrastructure requirements are also questioned. The final report will be issued this spring.

MUNICPAL ELECTION UPDATE

The Town of Fort Myers Beach will elect 3 city council members and Sanibel will elect 2 city council members on March 7th. The election for the Village of Estero has been cancelled as all of the incumbents were unopposed.

Cape Coral and the City of Fort Myers will each elect a mayor and 3 council members, with primary elections September 12th and general elections November 7th.

REAL ESTATE TAX REFORM PLAN

Real estate organizations worry that the tax cut proposal now being considered in Congress will lead to elimination of deductions for mortgage interest and property taxes. The proposal would increase the standard deduction to \$24,000 per household. The Tax Policy Center estimates that 84% of those who would otherwise itemize deductions would opt for the standard deduction and the current tax advantages of buying real estate would no longer be a factor, causing real estate values to decline. Federal Reserve Board economist David Rappoport estimates that killing the mortgage interest deduction entirely would reduce home values a 6.9% average nationwide.

MURDOCK VILLAGE DEVELOPING

In 2002, based on recommendations from ULI, Charlotte County initiated the assembly of thousands of platted lots to create an opportunity for major mixed-use development. Proposals from two master developers and a plan for an entertainment district floundered and the land has been relatively idle - until now. In November, Private Equity Group (PEG) acquired the 452 acre site from the County for \$11 million, which will be repaid to the developer over 2 years in return for road work and other improvements. Plans include 2,400 residential units, 200,000 sq. ft. of commercial and retail space, and a hotel. PEG also plans extensive public recreational amenities adjacent to the North Charlotte Regional Park, which is at the center of Murdock Village.
