SANIBEL REDUCES BUILDING FEES

The City of Sanibel is discounting Building Department fees by 50% until September 30th. The discounts are retroactive to November 1, 2022. This supercedes the 25% discount instituted in February and refunds will be processed for fees already paid...

SELF-STORAGE PROJECTS ON HOLD

Cape Coral City Council is imposing a 9-month immediate moratorium on permitting for self-storage projects. Applications already submitted will be processed but no new applications will be accepted until at least January 2024. Storage units reportedly comprise 11% of the City's commercial space and demand is driving increased development of the facilities.

GREATER DUNBAR INITIATIVE

ULI's Signature Lee County event will feature the Greater Dunbar Initiative and the Housing Authority of the City of Fort Myers. Speakers include Housing Authority Director Marcia Davis, Lee County School Board Member Debbie Jordan, Dan O'Berski, managing broker of Trinity Commercial Group, and Sandra Seals, senior VP Development, with McCormack Baron Salazar. The event is May 11th at the Collaboratory in downtown Fort Myers.

US 41 TRAFFIC RELIEF PROJECTS

The City of Bonita Springs is proceeding with design and permitting for a new roadway in the northwest quadrant of the US 41 and Bonita Beach Road intersection. Florida Department of Transportation (FDOT) proposals to deal with increasing congestion at the intersection are in the project development and environment phase. The two FDOT alternatives considered would both require expanding Bonita Beach Road to 6 lanes.

FLOOD INSURANCE RISK RATING

The Federal Emergency Management Agency (FEMA) is reviewing the pricing formulas in Risk Rating 2.0, according to Homeland Security, the department that oversees FEMA. Grant programs are also being reviewed to provide relief to businesses and property owners. The most recently revised FEMA Coastal Risk Map Project for Lee County became effective in November 2022. Collier County floodplain maps are on their Grow

LEGISLATIVE ISSUES TO WATCH

The 2023 Florida Legislative regular session is underway and key issues for the business community include:

Affordable Housing - The "Live Local Act" (SB 102) has passed and been signed by the governor. It includes \$711 million for affordable housing projects through the Florida Housing Finance Corp. and increases the money that goes into the Sadowski Trust Fund by adding a portion of the revenue from online sales taxes. The legislation was supported by the Florida Association of Realtors.

Economic Development - Enterprise Florida, the state's business-recruitment agency, is again facing elimination as the House Appropriations Committee has passed a bill (HB 5) that would transfer the agency's funding, currently \$13 million, to the Department of Economic Opportunity. Senate and House budget negotiators have agreed to increase the Job Growth Grant Fund from \$50 million to \$75 million to provide funds for job training programs and regional infrastructure.

Water Quality - Bills are proceeding in both houses (HB 1197, SB 1240) that would prohibit local governments from regulating water quality, pollution control (including local fertilizer ordinances), and wetlands. Regulation would become the responsibility of state agencies.

Land Development - Proposed bills (HB 671, HB 383) seek to reduce the time limits that local building departments have to respond to permit applications and requested zoning changes, variances and development orders. Other bills (HB 359, SB 540) would allow prevailing parties to collect attorney fees and costs in court challenges to small scale development amendments to land use plans. All are still working through committees.

Tax Relief - The Senate Appropriations Committee has approved a package of tax breaks (SPB 7062) that includes \$32.9 million in tax credits for brownfield site clean up projects and offers property owners a refund of up to 50% of the cost of installing greywater systems.

Commercial Lease Tax - a proposed package of tax breaks in the House of Representatives includes a 1% reduction in the commercial lease tax. Two years ago, the Legislature directed the tax to be reduced to 2 percent when revenue from sales-tax collections on out-of-state retailers replenished the Unemployment Compensation Trust Fund, depleted during the pandemic. The Fund is expected to be replenished in the coming fiscal year.
