WATER SHORTAGE LOOMING

Supplying Florida's growing population with freshwater is a cause for concern, according to the Annual Assessment of Water Resources by Florida's Office of Economic and Demographic Research (EDR). The report focusses on the major investment in infrastructure projects needed to maintain status quo of supply and demand. While Florida's Legislature has worked to create a dedicated funding source for water projects, Florida TaxWatch asserts that the state needs to implement a Five-Year Project Work Program for water resource projects similar to the Department of Transportation's Five-Year Work Program.

The Legislature intends that sufficient water be available for all existing and future beneficial uses and natural systems, while avoiding the adverse effects of competition for water resources. The Department of Environmental Protection (DEP) is vested with the responsibility and power to accomplish conservation, protection, management, and control of state waters. DEP delegates powers to the five water management districts to achieve these goals. Florida Statutes Chapter 373 provides the districts with broad authority to implement regulatory and non-regulatory programs to address water supply, water quality, natural resources, flood protection and floodplain management.

SWF ECONOMIC ALMANAC

The Regional Economic Research Institute (RERI) at Florida Gulf Coast University (FGCU) has published the *Southwest Florida Economic Almanac Series*, a comprehensive collection of over 30 databases on Charlotte, Collier, Glades, Hendry, and Lee Counties. Topics include real estate, finance, housing, agriculture, government spending, demographics, and more. The searchable document is available at the <u>RERI webpage</u>.

CLIMATE CHANGE FORUM

A Public Forum on the Impact of Climate Change in Our Community will be held at Florida Gulf Coast University (FGCU) on November 12th. The program is the first of a two-part series addressing climate change, issues and solutions, and sustainability with a focus on the greater Estero area. The free forum is supported by the Water School at FGCU and public involvement is encouraged. Greg Tolley, executive director of the Water School will moderate the forum, which includes experts in marine science, local water resources, and the environment.

FLOOD INSURANCE DEADLINES

Lee County, Cape Coral, Fort Myers Beach, Bonita Springs, and Estero are now in a probationary process and have until November 18th to resolve any deficiencies in their reporting to the Federal Emergency Management Agency (FEMA). If the deficiencies are not satisfied by that date, the Community Rating System ratings will be retrograded and discounts will end April 1, 2025. The ratings provide discounts to flood insurance policy holders. In April, FEMA withdrew the current ratings, citing that the communities had bypassed federal rebuilding rules and failed to provide required documentation of hurricane rebuilding management efforts. Fort Myers Beach, Cape Coral, Bonita Springs, and unincorporated Lee County have the #5 rating (25% premium discount) and Estero has the #6 rating (20% discount).

In September, Congress passed a resolution continuing funding of the federal government through December 20th. The bill included the extension of the National Flood Insurance Program (NFIP) through that date. If the federal budget is not passed or the program extended, NFIP will not be able to issue new policies after December 20th. The National Flood Insurance Program Reform and Reauthorization Act of 2023 (SB 2142) would reauthorize the program through FY 2026 but it remains mired in Congressional committees. The Department of Homeland Security has also submitted 17 legislative proposals to reform the the NFIP.
